## William A. and Virginia "Gynnie" Franta Building A Legacy

In 1970, William A. Franta joined the Board of Trustees at Goldey-Beacom College. Although he passed away in 1999, his impact on the College will live in perpetuity through a generous \$2 million gift and an endowed tuition scholarship from Bill and his loving and devoted wife Virginia "Gynnie" Franta.

Throughout his career at the DuPont Company as a research chemist and executive, Franta appreciated the diligent work of the company's secretarial and accounting personnel at all levels. He noticed that many of these largely unsung contributors to the company's successes during the mid-1900s were from Delaware families who, as the farming industry employed an evershrinking portion of the population, needed to be trained for careers in business. For decades, Goldey-Beacom College provided that training, qualifying hundreds of people for participation in Delaware's emerging corporate economy. Franta regarded that as a noble mission and Goldey-Beacom as a strategic community asset.

When Franta retired from his service on the board of the Alfred I. duPont School District, his attorney and Rhodes Scholar colleague, William Poole, persuaded him to accept a position on the Goldey-Beacom College Board of Trustees. He served with pride as a member, and eventually chair, of the Board of Trustees, during which time the College relocated from its cramped quarters in downtown Wilmington, to its present campus on Limestone Road. As the digital age dawned, he foresaw the need for the College to offer students a range of courses to prepare them to exploit increasingly sophisticated business technology. At his retirement from the board, Franta was satisfied that Goldey-Beacom – by then serving students from many states – was continuing to offer career-focused education at an affordable cost.


This is a very exciting time in the history of Goldey-Beacom College, and I am proud to be part of such an impactful project. I can't wait to see campus in fall 2020!"




As DiSabatino stood before graduates representing 45 countries, he related his own experience from his immigrant family who recognized struggle and sacrifice.


"teacher", but also as a mentor for students in his field. He often counsels with his students, encouraging them to attend field-related events, and helping them network for career opportunities.

## Building a Legacy — Alumni Board Member Adelaide Orsini '48

If ever there was a woman who personified the adage: 'you're only as old as you feel', it would be GBC alumna and Alumni Association board member Adelaide Orsini.

Orsini is a second-generation Italian American whose parents were born in the Abruzzo region of Italy. Her father, a strict disciplinarian, advised her from a very young age, "First you get the education, then you get the love." Education became a passion of Orsini's from that moment on and remains one today.

Upon being informed by a teacher at Wilmington High School that Orsini would never get the hang of shorthand or amount to anything, her mother promptly met with John

Leach at Beacom College to enroll her in a secretarial course. Orsini began commuting to the Beacom College campus at Tenth and Jefferson Streets in Wilmington to take courses in the mornings, while working at Wilmington Savings Fund Society part-time in the afternoons.

Orsini took on full-time hours at WSFS after receiving her Associate's degree from Beacom College in 1948. She quickly worked her way up to the president's office, reporting directly to Thomas Tatnall. She eventually became assistant secretary of the bank, an unprecedented achievement for a woman at that time. Throughout her career, she served on executive committees for the National Association of Bank Women, the Administrative Management Society, the Bank Administration Institute and the American Institute of Banking.

After 36 years with WSFS, Orsini retired. In 1982, she received the honor of being in the first class of Distinguished Alumni Gallery (DAG) recipients at Goldey-Beacom College.

Orsini continues to be an integral part of the College today. Her spirited observations and positive energy serve the alumni board well and infuse momentum into quarterly meetings. She remains deeply committed to providing scholarship funds to those in need and is immensely proud of her Goldey-Beacom roots. In her own words, "That's where my career started, and I'm so proud to be a member of the GBC community."

His first internship was with the insurance brokerage firm Ascela in Newark, DE. This internship introduced King to the insurance world and terminology like HMO and PPO. He spent the majority of his time directing a team on the implementation of a new database, merging accounts from the old database into the new one.

King's second internship was with the government of Cecil County, MD. As this was an internship rooted in human resources, his responsibilities were unlike the ones assigned to him at Ascela. He created brochures and fliers to market various county events, while introducing a facelift to the county training presentation, contributing a more current and interactive format. He also coordinated an annual training schedule for county employees and volunteers. However, the project that impacted him most was taking photos of county employees in their work settings, and then compiling those photos into a slideshow to display at career fairs to give insight into the everyday happenings at Cecil County government.

Schweitzer-Mauduit Inc. (SWM) in Middletown, DE is the latest company to which King brings his many talents. His third (and final) internship with this global engineering and manufacturing company differs significantly from the first two, and King is finding that no day is ever the same in the world of human resources. Though he continues to assist with creating brochures and fliers, he is also testing safety training programs, creating new hire folders, and entering PTO for employees. Most exciting to King, however, is that he is now recruiting for open positions. Since his ultimate goal is to one day become a talent acquisition manager, this was the prime opportunity he needed, not only to gain relevant work experience, but also for the reassurance in his own mind that this is something he will be happy doing for the rest of his career.





## Taking Life By the Horns – No Bull Micky Jones '07

Micky Jones grew up with dreams of someday owning and operating a father and son business – a dream that he and his father shared and had discussed many times over the years. After attending a festival and seeing a bungled mechanical bull ride, a light bulb went off in his head, and he knew in that moment that he could do better. After initial research, Jones decided that running a mechanical bull business had the potential to be a fun and unique venture as well as an enterprise with low overhead. Since it was primarily a weekend business, it would not affect his full-time job.

With a background in business development and marketing, Jones had a

unique advantage over his competitors. He quickly became the only mechanical bull business fully licensed and endorsed by the PBR (Professional Bull Riders) in Maryland, Pennsylvania and Delaware.

By the Horns has grown its fleet of bulls from one to three and has become the number one rated mechanical bull rental company in the area, a feat which brings Jones immeasurable pride. However, it hasn't always been a smooth ride. As Jones points out, "When you start a business, there is always pressure to do everything right and grow without sacrificing quality and service. As we grow, so do the obstacles and costs, and we are certainly not immune to them."

According to Jones, the biggest obstacle he currently faces is labor because By the Horns LLC operates mainly on weekends. Jones is very careful about who he selects to run his crews, and this comes at a monetary premium. In his mind, this meticulous selection is well worth every penny to ensure a polished and seamless operation. He feels truly fortunate to have a hardworking and trustworthy team of top-notch professionals.

Jones feels strongly that the knowledge and business confidence he gained at GBC not only helped to propel his professional career, but also enabled him to take the leap and start his own business. He believes that GBC's 'real-world approach' to business provided him the ability to navigate obstacles and solve problems that commonly arise when starting a business.

When asked about his fondest memories of GBC, Jones reminisces about being a scholarship athlete and winning a conference championship while on the Men's Cross-Country Team. "We had an absolutely amazing squad," he recalls. "And with the help of Rob Netta, Brad Paski, Matt Lang, Keith Miller, and myself, we were able to have an unstoppable season and win our Central Athletic Collegiate Conference (CACC) championship. Being part of a great team with such talented individuals really helped shape who I am as a business owner. You are only as strong as the team you have around you."

### Innovators in Application Development

Apple icon Steve Jobs says, "Innovation distinguishes between a leader and a follower." Well, if that is true, these fast-moving, young entrepreneurs are born leaders. Goldey-Beacom College alumni Chahin Aghrim and Artur Zvinchuk are driving their innovative ideas into the world of mobile application development.

Their GBC degrees in information technology and finance, respectively, have helped prepare them for this highly-competitive field.

They have already launched one app and are on the cusp of launching their current project. They both say, "We are two lucky guys," but it's probably not so much luck as it is hard work and dedication.


#### **SmartStudents**

Their first app, SmartStudents was launched in August 2017 while both were on the GBC Men's Soccer Team. Developed from a sense of necessity, Aghrim says, "SmartStudents is a mobile marketplace that enables students to trade all kinds of stuff on campus. This simple idea of communicating with other students to purchase textbooks for an average purchase price of about \$30 per book was the inspiration for this app."

"We believe in using technology to connect college students across the country," Zvinchuk said. "Together, we can achieve our full potential."

Goldey-Beacom College was the test site for SmartStudents. Now, Aghrim and Zvinchuk partner with many other institutions including Rowan University, Drexel University, University of

Pennsylvania, Jefferson University, Temple University and Rutgers University to help other college students buy and sell textbooks and other items.

Aghrim and Zvinchuk have been best friends since they attended Friedrich-Ebert High School in Germany. Both were stand-out high school soccer players who each received a soccer scholarship to attend GBC. Turns out, attending GBC was one of their best decisions ever. In 2017, the College's Men's Soccer Team won the Central Atlantic Collegiate Conference (CACC) championship.

#### Youpendo

Ironically, the same qualities that earn championships also determine success. "Trust and discipline are important," Aghrim says, "you just need small ways to add large value to other people's lives." Driven by their interest in application development, marketing and information technology, the pair have combined their innovative thinking and

entrepreneurial spirit to develop their latest app – Youpendo.

Youpendo allows the user to send and receive heartwarming messages in the form of snaps from anywhere around the world. How does it work? "Log on, read the inspirational question (perhaps "what advice has changed your life"), and respond with a short video," said Zvinchuk. "The video is sent like a "paper plane" and then viewed by people around the world who can comment and thank the sender."

"Everyone is asking us – what does Youpendo mean?" Zvinchuk said and they both smiled. "I was combining random words one night, then came upon the Swahili word for love – upendo. This became Youpendo. Simple."

#### Student-Athletes Bring Home Third Place for the 2018 NCAA Division II Award of Excellence

How often do young college students want to spend time with residents from a retirement home? Well, it's the norm for Goldey-Beacom College student-athletes who began visiting residents at The Summit retirement community on Limestone Road over a year ago.

What began as a service project through GBC Cares, the Department of Athletics' community service branch, quickly became a heart-warming, mutual friendship based on – believe it or not – shared familiarities. Since most of the College's student-athletes are international students, and almost all veterans have spent time overseas, it made for great conversation since many of the veterans had been stationed in small European towns where the students had either grown up or visited.

After listening to the veterans' stories, students would return to the College after each visit so happy to have made new friends – despite the generational gap. It's no surprise that they came up with the idea of interviewing their new friends and retelling their stories in a book.

over 40 veterans from The Summit. "We could not be more proud of our students," Associate Athletic Director Jeremy Benoit said. "I brought this idea to our

Student-Athlete Advisory Committee and Lightning Studio (a multimedia student organization) last year and they hit the ground running. This project is the essence of community engagement." Benoit worked closely with The Summit and student-athletes to conduct interviews and transcribe these stories to honor the veterans' military service. Primarily led by Lorenzo Busra Ribeiro da Gama from the Men's Soccer Team, Geoff Stone from Lightning Studio and Benoit, other partners included GBC Lit (a literary student organization) and members of the Athletics and Development departments.

In November 2018, the GBC family joined The Summit residents and their families for a Veterans Day breakfast to honor the men and women who gave so much through their military service.

News of the National Collegiate Athletic Association (NCAA) award came a few months later. In January 2019, Goldey-Beacom was presented a \$1,000 check at the NCAA Convention in Orlando, FL for their third-place finish. The NCAA gives this award annually to a Division II school for an event or activity that exemplifies any of six Division II attributes: learning, balance, resourcefulness, sportsmanship, passion and service. The project then went on to receive the Central Atlantic Collegiate Conference (CACC) Community Engagement Award in July, earning another \$1,000 which brings the current fundraising total to nearly \$3,000.

Having visited a nursing home every week as a child, Benoit is deeply committed to the veterans and to this project. "Every dime that is raised from this project (including the \$1,000 from the NCAA Division II Award of Excellence) is going to be donated to the Fisher House for the Families of the Fallen," Benoit said. "This amazing organization provides temporary housing to the families of fallen service men and women as their loved ones return stateside at the Dover Air Force Base en route to their final resting place."

# Meet . . . Colleen Perry Keith

After an exhaustive presidential search, in February 2019, the greater Goldey-Beacom College community announced the appointment of Colleen Perry Keith, Ph.D. as the institution's fourteenth president. We didn't know what to expect, after all, Dr. Keith was bringing two major firsts – first female president and first president from outside of Delaware.

In fact, one of our first questions was – why Delaware? We soon learned that Dr. Keith wasn't really looking to leave her post as president at Pfeiffer University in North Carolina, but she had one major life goal in mind – being closer to family. Her adult son lives in Washington, DC and her parents live north of Syracuse, NY. So, it didn't take long for Dr. Keith, her husband Barry and their two dogs Daisy and Bailey, to pack up and head to Delaware. Keith says, "Delaware positioned me much closer to both of those "tugs on my heart", so when I was made aware of the opening at Goldey-Beacom, I felt I owed it to myself to check it out."

"It's very rare," she continued, "when a challenging professional position, especially one for a college president, can dovetail with a personal goal. Being the president at Goldey-Beacom College allows me that professional challenge and fulfillment while also bringing me closer to family." I should mention that she also whispered the word – grandchildren.

It was a pleasure to engage with Dr. Keith's sense of humor and her relaxed approach as she talked about her home next door to the College and her plans for the coming year and beyond. Her enthusiasm was contagious and her ideas were so compelling, but when the conversation turned toward serious issues affecting the College, a strong, confident leader emerged from the laughter. This is why I have to share our conversation in her own words.

1. Describe how you felt walking onto campus on your first day.

"I felt very lucky, blessed and excited.

Prior to my first day, I had walked
around the campus several times on daily walks.
I was quite taken with the obvious care that
Goldey-Beacom has for its facilities. Our campus
is in great shape! While under construction,
some sidewalks have to be temporarily closed but
because GBC cares, we had built new sidewalks
to care for the needs of our campus community.
Many places would have just put down mulch
walkways – we actually paved new walkways.
That may seem like a mundane or inconsequential
thing, but to me it demonstrated care for our
campus community. It's a little thing that
subconsciously speaks volumes."

#### 2. What are you most looking forward to?

"Ever since my first experience with the Presidential Search Committee, I have been looking forward to the creativity that is inherent with helping a college to envision, plan for and implement its plan to claim a bright future. Leadership at GBC should be a fun experience, and both personally and professionally fulfilling. We have some long-term leadership who bring historical knowledge, and I am especially eager to tap into their strengths and insights."

3. How about your new on-campus home? Have you always lived on a college campus?

"This is my third – and I am hoping my last – college presidency. I did not live on campus at Spartanburg Methodist College but did at Pfeiffer University. There are pros and cons to both. For Barry and me, we love the on-campus experience because we can get to know our students better and see them at their very best and sometimes at their very worst. It's fun to have the informal interactions, and our dogs are student magnets when we walk them on campus. I believe living on campus creates closer relationships with students and enhances the student experience."

4. You've only been here a few weeks. What are your initial thoughts about the opportunities that lie ahead?

"When I think about the College during its historical time, I am reminded that we all stand on the shoulders of those who came before us. I am deeply indebted to Presidents Baldt, Ilyas and Wirt for their work at Goldey-Beacom. Without those gentlemen bringing their unique gifts to the College, I would not be able to use my gifts to move us to the next level. To use a football analogy, each president before me moved the ball down the field. It's now my job to use my gifts to move that ball even further. Another series of first downs! We have a strong financial and academic foundation thanks to their work. Now we need to create our vision and goals collectively, from the "bottom up," with all stakeholder voices involved. That's our first big opportunity."

5. You are a two-time sitting president. If you had to finish the sentence, "I'm certainly happy that I am bringing my experience with how to ...." How would you finish the sentence?

"I am certainly happy that I am bringing my experience in planning and execution of those plans to GBC. We have a good strategic plan in place, but it's a bit too operational at this point. We need to set a bold goal and vision that answers the question, "to what end do we do what we do?" From there, we can plan and budget toward that goal and that vision."

Tell me how community partnerships and community engagement will help shape GBC's future.

"It's been my experience, and certainly my strong belief, that colleges operate best when they are in meaningful partnership and dialogue with the communities in which they live and serve. GBC's













goals will have a positive impact in Pike Creek, New Castle County, the City of Wilmington and the state of Delaware. We are absolutely stronger when we work with the institutions and agencies in our community for the collective good. By working together, we will all maximize financial resources and drive economic development as well as attract and retain strong students, faculty and staff. By partnering, our college, community, city, county and state stars can rise!"

7. Education Dive is a leading industry publication operated by Industry Dive that provides original analysis on the latest happenings in the education industry. They tracked more than 80 nonprofit colleges and universities that experienced closures and consolidations from 2016 to present (not including for-profit colleges). Tight budgets and small endowments factored into announcements. A 2016 report from Ernst & Young affiliate, the Parthenon Group, found 800 colleges vulnerable to "critical strategic challenges" due to their small size, compared to a much smaller share of colleges with enrollments over 1,000. The report lists several risk factors for small colleges amid the current environment of consolidation in higher education including enrolling fewer than 1,000 students; the absence of online programs; tuition increases greater than 8 percent

and discounts higher than 35 percent; and depending on tuition for more than 85 percent of revenue.

While other Colleges are facing major issues and closing at an unprecedented pace, does GBC face any of these issues, and if so, how will you address them? What is GBC's best asset to move it forward?

"The current higher education environment is challenging. The Parthenon Group report is spot on and enrollment challenges are only going to increase. For the past 15 years, the number of high school graduates has been stagnating, which means colleges and universities need to broaden their student base in terms of geography, age and life experience. Then, the pool of high school graduates is more diverse than ever, and colleges need to be accepting of this if they hope to attract the traditional-aged undergraduate.

Some of the other risk factors identified by the Parthenon Group are easily identified here at GBC as well: we don't have on-line programs and our tuition discounts are high. What GBC has, however, as a hedge against these factors is an incredibly strong endowment of \$150 million and strong enrollment in our graduate program. We will not be facing closure. Our endowment gives us some breathing room to plan our future and then move forward. We cannot, however, sit

back and relax and do nothing. We need to set a clear and strong vision and put a strategy in place that gets us to that vision. We will address any threats to our place in the higher education environment through sound planning, smart decisions based on realistic assessment of the data we collect and focus on the strategic implementation of our plan.

Not surprisingly, our best asset to move GBC ahead is our people. We have employees at GBC who have served here for decades. While sometimes long-term employees can be resistant to change, I am finding that our employees are ready to embrace change in the context of planning for a future that builds on our strong past. They have said we can't remain the same college we were in 1970 or 1980 or 1990. We have to be a college that is relevant in 2020 and 2030 and 2050 and beyond. Our human capital will move us ahead. I'm counting on them!"

8. Other top issues being discussed nationally are affordability, student and campus safety and security. What are your plans to address these issues?

"We are looking seriously at both issues. To address affordability, we have a study underway to review our tuition rate: is it too high? About right? Too low? GBC has had a long-standing commitment to offering an affordable education, which has served to decrease the average loan indebtedness for our students. Many colleges, even state-assisted colleges,

have seen increased loan indebtedness, so we have some bragging rights there. Between 2011-2012 and 2018-2019, we decreased the number of students – both undergraduate and graduate students – from taking loans by 25 percent with the College's Affordability Assurance Award. This award brings the actual undergraduate tuition down to just over \$10,000. Our net cost to families is amazingly low compared to our competition.

The topic of student safety is something that keeps all college presidents up at night. I know I speak for my colleagues when I say we worry about this even when we know we have taken every possible precaution. At GBC, we have been fortunate that we haven't had any major issues. We know this reality could change at any moment. We have an extremely active security force 24/7, who make regular rounds and monitor our cameras. They respond quickly and effectively and, if needed, place a call to our armed colleagues with Troop 6 of the Delaware State Police, who can respond quickly. Still, we are considering our current practices and managing any potential risk. We will soon make a decision about possible changes to our security operation going forward.

The topic of campus safety, though, is far broader than arming campus security personnel. We must plan, train and make sure that all members of the College community know what to do in the event of any emergency. GBC has a collegewide committee that annually reviews our policies and procedures related to emergency management, and plans and implements regular training for all employees and students. I'm a new employee and I know the plan – and I am grateful we pay close attention to training. While no one can ever anticipate everything, I feel equipped to take action in the event I ever need to."

#### 9. What will success look like in the future?

"I think that the changing demographics are going to force colleges to adapt in ways that we can't even imagine today. The population is shifting away from majority white, people are moving to the Southern states and birth rates are in decline. I don't have a good feel yet for what success will look like for GBC, but I suspect it will include delivery models that include more on-line learning and more partnerships with other institutions or corporations to offer training. It will probably include quality, shorter-term programs that offer focused career skills and an active role in research and development so that GBC and colleges like us can remain competitive and stay on top of the

trends. Successful colleges will be the most agile ones; the ones most willing to embrace change."

## 10. Tell me about your goals for your first 100 days.

"As I write this, I am 31 business days into my first 100 days. In the 69 days I have left, I hope to meet and talk with as many of our faculty, staff, students, alumni, trustees and community members as I can to hear their GBC story. I want to understand their perceptions so that as we move into a

comprehensive planning process, I can be sure that we focus on our successes and correct where we may have come up short. I want to welcome our largest incoming undergraduate class in at least the last decade and welcome back our returning students. I want to get to know my new GBC family and friends so that in my second 100 days, we can all work well together."

12. Rumor has it that two, four-legged children rule the roost. Is this true? Who's calling the shots here?



"Oh goodness yes! Barry and I have always had dogs: boxers, miniature schnauzers and English bulldogs have been part of our family over the years. Currently, we have Daisy, who is two and a half and Bailey, who is 24 weeks old. Both are English bulldogs and both are the sweetest girls we've ever had! We are excited to introduce them to the GBC community . . . and Bailey is the one who calls shots!"

#### 2005 - 2006 Golf Team

The 2005-2006 Golf Team has made major contributions to the department's history. The team was in its third year as a full NCAA Division II member when the Lightning ran away with the NCAA East Regional championship, becoming the first team in school history in any sport to win an NCAA Tournament event. The last of the squad's three victories that year saw GBC go wire-to-wire in the three-round event, winning by 24 shots. That squad was highlighted by 2017 GBC Athletics Hall of Fame inductee Michael Tobiason, who won the regional with an 8-over-par 221 that included a 3-underpar 68 in the final round. Tobiason, a participant in the 2011 United States Open, won five titles in 2005-2006 and averaged 74.83 for the season. Steve Cutler also was a major part of that team by sharing the CACC individual title with Tobiason at 144. He averaged 77.40 that season over a personal-best 30 rounds, eventually closing with a 78.07 career average over 83 rounds and a school-best 136th national ranking in 2006-2007.

#### 41 Student-Athletes Earn CACC Academic Honors

The GBC Athletics Department honored 41 student-athletes who attained status on the 2018 – 2019 Central Atlantic Collegiate Conference (CACC) Academic Honor Roll at a celebration breakfast.

"Our student-athletes continue to perform at a very high level in the classroom, and we hold this breakfast as an annual opportunity to celebrate their academic achievement," Director of Athletics Dr. Thomas Brennan said. "Considering the great lengths they go to support our student-athletes, it was a great moment to be able to celebrate them, as well."

In the fall semester, the Lightning saw 13 of their student-athletes notch a 4.0 GPA for the semester (the same number as the fall of 2017) and had 65 percent of their student-athletes end with at least a 3.0 cumulative GPA. GBC also sports a 3.198 GPA among its student-athletes, higher than the College's GPA among non-student athletes.

To be eligible, each student-athlete must maintain a 3.5 cumulative GPA, be at least a sophomore and have been at the college at least one full academic year.

#### **Softball – Stephanie Topolie '02**

Stephanie Topolie never competed in softball prior to arriving at Goldey-Beacom College, but she played four strong seasons making an indelible mark primarily as a center fielder. Topolie set the bar by graduating first in school history with 212 hits, 108 RBI, 10 home runs, 22 triples and 123 runs. She was second with 48 doubles and seventh with a .414 batting average. Her marks for hits, RBI, triples and runs remain school records. Topolie's effort in softball helped her to be named a 2000 NAIA Scholar-Athlete, 2001 All-Central Atlantic Collegiate Conference and to the 2001 CACC All-Tournament Team. She was instrumental in the 2001 unit ending second in the league and winning 17 conference games, both of which remain school records. Topolie guided the 2000 squad to the CACC Tournament for the first time in team history. She was part of the first women's basketball season in school history, averaging 12.1 points and 3.6 rebounds during the 2000-01 campaign. She also competed in volleyball for three seasons, being named All-CACC and to the CACC All-Tournament Team in 2000. While no known statistics can be found, many people say that Topolie never came off the court.



#### Track and Field Closes Its Season at the CACC Championship

Last spring, Goldey-Beacom College continued to show growth in its Athletics Department with the addition of Men's and Women's Track and Field, bringing the number of programs to 13. Soon after launching the program, the College didn't have to look far for a new head coach. Andrew Shearer, who has served as the Cross Country coach since 2016, quickly took the reins to also serve as the head coach for the Track and Field teams.

Both teams closed their inaugural season at the Central Atlantic Collegiate Conference (CACC) Championship in Lakewood, New Jersey. The men's team finished ninth, and the women's team closed 12th.

This award-winning, dynamic basketball player has quickly become the most dynamic men's basketball player in the NCAA Division II region. This Sayreville, New Jersey native is a standout player on the court and academically focused when the clock is not running down.

## NCAA Ethnic Minority Graduate Scholarship

The NCAA Minority Opportunities and Interest Committee recently awarded Taite the NCAA Ethnic Minority Graduate Scholarship. He will receive a \$10,000 nonrenewable award to be used during the 2019-20 academic year as a full-time graduate student in a sports-related program.

As a scholarship recipient, Taite attended the 2019 NCAA Career in Sports Forum

(CSF) in Indianapolis last June. Hosted annually by the NCAA, the CSF is a four-day educational event which brings together two hundred selected students and student-athletes to learn about careers in sports, with a primary focus on intercollegiate athletics. It is designed to assist student-athletes in charting their careers in the business, giving them the opportunity to network and learn from current athletics professionals.

## Second Team CCA All-East Region

Alumnus Corey Taite has amassed what would fill a trophy case of awards during his time with Goldey-Beacom College. His most recent honor was being named second team Conference Commissioner's Association Men's Basketball All-East Region.

During his senior season, Taite continued to show his prowess as one of the nation's top players after being picked first team All-Central Atlantic Collegiate Conference and to the league's All-Tournament Team, both for a second straight year. He has consistently demonstrated his skills as a strong shooter, passer and defender. This honor came one year after he was selected as the CACC Player of the Year, first team All-East Region by both the CCA and NABC in addition to making the league's

All-Tournament Team. Taite also landed on the Top 100 Watch List for the Bevo Francis Award.

Taite's statistics prove his worth. He ended ranked 45th in the nation with 20.5 points per game, 16th with an .899 free throw percentage, 20th with 161 free throws, 64th with 574 points, 64th with 35.5 minutes per game, 70th with 1.82 steals per contest, 78th with 51 steals and 90th with a 1.95 assist-to-turnover ratio.

Taite scored in double figures 26 times this season, including a season-best 40 points against Caldwell in the CACC quarterfinals, and netted at least 20 points 14 times. He also poured in at least 35 points on four occasions, including that amount in the regular-season finale against Wilmington (DE).

All of this has been valuable for Goldey-Beacom which closed second in the CACC South Division and advanced to the conference semifinals for the second straight year.

#### Dan Frick Named CACC Women's Soccer Coach of the Year

Women's Soccer Head Coach Dan Frick has been named Central Atlantic Collegiate Conference (CACC Coach of the Year for the second time in three seasons. Frick is 39-15-3 in his third year and has seen his team make the conference tournament each season. Accomplishments for the Lightning (15-5, 11-1 CACC) include breaking the school record for most wins, most conference victories, most home wins with nine and a team-record 63 goals.

In the 2018 season, the Lightning won their first six games both overall and in the conference for the best starts in team annals and recorded their third straight season of double-digit wins for the first time in program history. They also marked the first time Goldey-Beacom played in the CACC semifinals in consecutive years. The 4-0 quarterfinal triumph over Nyack also marked the first time in program history it had won a conference tournament game in back-to-back seasons. Goldey-Beacom's 39 victories under Frick's leadership is a school record for a three-year period.

#### Meet New Head Coaches Tommy Ellison and Kareem Bryant

New eras are underway for two of Goldey-Beacom's athletics programs with Tommy Ellison named the new head coach for golf and Kareem Bryant getting the top spot for women's tennis.

**TOMMY ELLISON** – Ellison has served as an assistant coach at Goldey-Beacom since 2017. He currently serves as the head golf pro at Ed Oliver Golf Club.

Previously, Ellison was the head golf pro at Brandywine Country Club and an assistant pro at Sussex Pines Country Club. He has also been an assistant coach for seven seasons at his alma mater, the University of Delaware.

A 2009 graduate with a B.A. in European History, Ellison played four years at the University of Delaware. He earned team MVP honors in 2008 and the Sportsmanship Award the year prior. He ranks seventh on the career scoring list with a 75.1 average, pacing the Blue Hens in scoring both in 2007-08 with 74.85 and 2008-09 with 74.35.

**KAREEM BRYANT** — Bryant previously served as the executive director at the Rodney Street Tennis and Tutoring Association. He worked with the board of directors, developed resources for fiscal responsibility and handled community outreach through the directors.

Since 2006, he has been a national coach and middle states zonal coach for the United States Tennis Association. He coached many players in the junior ranks, developed plans for player improvement and traveled with both the players and their families to national tournaments.

Bryant also has been the director of Neighborhood-Based Programming for Legacy Youth Tennis and Education since 2012. He has designed, implemented and improved these programs by creating a manual for the tennis curriculum. Bryant also nurtured partnerships with schools and the community to develop community based partnerships and worked with colleagues to sustain program initiatives.





#### Women's Tennis Advances to the NCAA Sweet 16


For the first time in program history, GBC Women's Tennis won their NCAA East Region bracket and advanced to the Sweet 16 which took place in Altamonte Springs, FL this past May.

Ranked third in the East Region, Goldey-Beacom was the highest-ranked among any school from the Central Atlantic Collegiate Conference (CACC) including 2018 CACC Champion, Wilmington University. A pair of 4-0 victories over CACC foe, Concordia (NY), and Stonehill sent the squad to Florida where they would take on the University of Indianapolis in the Sweet 16. This match marked the furthest a GBC team has survived in an NCAA tournament, regardless of sport.

Goldey-Beacom (16-5, 7-1 CACC) this season captured a share of the league's regular-season crown for a third straight year and made its 11th straight appearance in the conference semifinals. The Lightning, who have played in the NCAA Tournament eight times, also have won 24 of their last 25 regular-season league matches.



#### Joe Kissel, 13-year Women's Tennis Coach, Retires

Goldey-Beacom's Women's Tennis program will have a new look for next season as Joe Kissel will retire after 13 years as the team's head coach. "Goldey-Beacom could not be more proud of the success that Joe Kissel has brought to the women's tennis program in his 13 years as head coach," said Director of Athletics Dr. Thomas Brennan. "Joe is a consummate professional who has demonstrated a real commitment to the concept of the student-athlete and who, during a highly successful career, has touched the lives of so many. His mark on the program and the College has undoubtedly been made. We wish nothing but the best for Joe and his family in retirement."

Kissel arrived in Pike Creek to a secondyear program still looking for its first win. He soon turned it into a powerhouse team that competed eight times in the NCAA Tournament and twice won Central Atlantic Collegiate Conference titles – 2016 and 2017.

Beyond all the victories, the relationship that Kissel built and fostered with the student-athletes he recruited has always been his greatest success. Over the years, his squad has included more than 40 student-athletes from 18 countries. The network of Goldey-Beacom Women's Tennis alumni remains strong today because of Kissel's commitment.

"Many coaches see recruiting as the worst part of the job. I love every minute of it; not necessarily the process, but the end result," said Kissel. "Few things are more satisfying than helping a young student-athlete fulfill her dream of coming to the US to earn a college education, while playing a sport about which she is passionate. It is extremely rewarding to watch these recruits mature into young women right before your eyes, and through social media, follow this growth after they graduate. These relationships have led to weddings and continued contact as 'my girls' have children of their own. Knowing, as a coach, you played some part in helping these students kick-start their lives is one of the most rewarding aspects of the job. It doesn't get any better than that."

Goldey-Beacom's accomplishments under Kissel extend beyond championships. He and the team have participated in community service activities such as the Tennithon to benefit the Delaware Tennis Foundation, and ball people for the Delaware Wheelchair Tennis

Championships. The squads have always excelled in academia, as well. At the conclusion of the 2017 - 2018 academic year, for the third consecutive year the team boasted a cumulative GPA of 3.7226 which was the highest of any athletic team at the College. In addition, most have gone on to complete their master's degrees at Goldey-Beacom or other colleges. But, perhaps more importantly, most former players are now gainfully employed in the US, and in their native countries, in their fields including accountants, international business managers, small business entrepreneurs and international soccer or tennis organization supervisors.

"Joe Kissel is a genuine, driven leader who has taken our tennis program to unparalleled heights," adds Dean of Students Chuck Hammond who previously served as the Director of Athletics. "His passion for helping student-athletes achieve more than they ever thought they were capable of on and off the tennis court is evident in his relationships with his players. To compete consistently on a regional and national level while displaying the highest level of academic success is truly remarkable. We thank Joe for his dedication to our student-athletes and wish him all the best in retirement."

Kissel's career at Goldey-Beacom represents so many accomplishments that we cannot list them all here. However, some highlights include USTA Middle States Delaware District Community Tennis Coach of the Year (2009) for his work in only four years at Goldey-Beacom; USTA Delaware District College Coach of the Year (2015, 2016); USTA Middle States College Coach of the Year (2017), USPTA Middle States College Coach of the Year (2017).

At the conclusion of the 2017-2018 season, the Intercollegiate Tennis Association (ITA) named Kissel the East Region College Coach of the Year. He was also selected by conference coaches the Central Athletic Collegiate Conference (CACC) Coach of the Year four times (2008, 2009, 2014, 2017).

His latest award was presented last October, when Kissel was inducted into the Delaware Tennis Foundation Hall of Fame for his record accomplishments at Goldey-Beacom, and more than 20 years of service to Delaware tennis.


